Opening Session: Team DUI -

Do You Know Who We Are?

As a member of the Pennsylvania DUI Association, you may have attended past annual meetings, but have you ever stopped and wondered who all these people are and what they actually do? Our membership is comprised of a mix of mostly Probation and Parole, Court Administration, Treatment & Prevention professionals, and Law Enforcement professionals. Martin Lockett grows up in a rough neighborhood in Portland, Oregon, and by the time he's fifteen, his parents don't know what to do with him. He and his friends commit crimes, drink, smoke marijuana, and eventually is sent to prison at age 19 for his part in an armed robbery.

Released three years later at age 22, Martin seems to finally turn his life around. He gets a good job, moves up in the company, enrolls in community college, and meets a nice young woman. He's proud to buy his first car, but his decision to get behind the wheel one drunken New Year's Eve leaves two innocent people dead, several families destroyed, and puts the twenty-four-year-old Martin behind bars for nearly twenty years.

It is in prison that Martin finally finds meaning and direction in life by channeling his efforts into an education that culminates in a master's in psychology and state certification as a substance abuse counselor. Devasted by the tragedy he has caused, he devoted the rest of his life to preventing others from following in his footsteps by sharing his powerful story at DUI victim impact panels, alcohol highway safety classes, high schools, and conferences across the country.

WEDNESDAY, NOVEMBER 15, 2023 WORKSHOP SESSION #1 - 2:30 P.M.

1A. The Addiction Problem in Pennsylvania: An Overview & How to Access Addiction Treatment Services - Presenter: Deb Beck, MSW, President, Drug & Alcohol Service Providers Organization of PA. This workshop will provide an addiction treatment clinician's perspective on the burgeoning alcohol and other drug addiction problem in Pennsylvania. The workshop will provide current information on the ever-changing federal and state health care environment, how state and federal laws inter-relate and how to go about accessing addiction treatment through these plans. The presentation will discuss coverage for and methods of access to addiction treatment through PA's Single County Authorities on Drug & Alcohol, PA's Act 152 of 1988, PA's Act 106 of 1989, the Affordable Care Act and the Federal Mental Health Parity & Addiction Equity Act. The presentation also will address questions such as: Why do overdoses and overdose deaths continue to rise in Pennsylvania? What can we do about it? What is appropriate treatment for people with addictions? Does treatment work? Is it different for criminal justice populations? Does forced treatment work?

1B. Verbal De-escalation and Dealing with Difficult Behaviors in Law Enforcement - Presenter: Amanda Jernigan, Outpatient Director, Gaudenzia. In this training we will look at the signs of escalating behaviors with a person and how to respond in a way to de-escalate the person and not continue to upset the individual. Also covered will be the reasons people escalate and how using a trauma informed approach could be helpful in the de-escalation process.

1C. Internet Drug Trends & Caffeinated Drinks -

Presenters: Shawn Noonan, DRE, Regional DUI
Program Administrator, PA DUI Association &
Corporal John Witkowski, DRE, Pennsylvania State
Police. This workshop will talk about drug trends that
appear and disappear as a result of social media
applications (i.e. Tik Tok, You Tube) that encourage
its viewers and followers to take part in some
"challenge" that results in the user feeling different.
Examples will include Nyquil Chicken Challenge,
Chroming, converting Sanitizer to Drinking Alcohol.
We, as a society, are driven by caffeine. What exactly
is this doing to our body? How much caffeine is too
much? Come and find out.

1D. Pennsylvania DECP Program Updates & Recognitions- Presenter: David Andrascik, DRE, Pennsylvania DRE State Coordinator, Pennsylvania DUI Association. In this session, the State Coordinator will provide the latest information on the DECP in Pennsylvania and nationally. Additionally, individual program awards and recognitions will take place. *This session is for DREs only.

2A.The Partnership of Medication Assisted Treatment and Traditional Substance Use Disorder-Why it Works -

Presenter: Amanda Jernigan, Outpatient Director and Andrew Schmitt, LCSW, Corporate Outpatient Director, Gaudenzia. This training will cover what Medical Assisted Treatment (MAT) is and how it has been proven to be beneficial to help treat those with substance abuse. A review of the types of MAT, how it is beneficial to those seeking treatment, and why it is not "replacing one drug with another" will be discussed. In addition, the training will cover what a comprehensive treatment plan should look to include, not just MAT, but substance abuse counseling as well.

2B. Vaping & Vaping Devices for Law **Enforcement -** Presenter: Christopher Shanley, Director, Allegheny County Pretrial Services & Corporal John Witkowski, DRE, Pennsylvania State Police. Vaping and vaping devices are nearly everywhere. Some people using these devices are simply vaping nicotine and some are using them for illicit drugs. This workshop will look at the most common vaping devices and how they can be used for substances other than nicotine. The workshop will also explore how vape users hide their devices in plain view. And finally, if you encounter a driver with a device; what else should be done.

2C. Reaching Underserved Communities in a Positive Way - Presenter: Corporal Aaron Allen, Heritage Affairs Liaison Officer, Pennsylvania State Police. This workshop will provide some strategies, tactics, and examples of successful outreach to our underserved communities across the state. Corporal Allen will also provide contacts and resources from their Heritage Affairs Unit to help our network successfully gather their community's leaders.

2D. New Jersey Supreme Court Case

Review- Presenter: Sgt. Michael Gibson.

New Jersey State Police, Former DECP State Coordinator. The Previous New Jersey DECP State Coordinator Mike Gibson will discuss the recent New Jersey Supreme Court case that ruled on the admissibility of the DECP. Many experts that provided testimony throughout the 2-year hearing were judged on their credibility and reliability. Many of those experts have and will provide testimony in PA Courts. *This session is for DREs.

The resources available from the PLCB's public website to access general and specific license information will be demonstrated. This information is valuable to understanding what is permissible and prohibited in a licensed business as well as awareness if a licensed establishment is operating with restrictions under a Conditional Licensing Agreement. *This session is designed for Alcohol Highway Safety School professionals, Treatment and Prevention Specialists.

3D. Curricula Updates - Presenter: David Andrascik, DRE, Pennsylvania DRE Program State Coordinator, Pennsylvania DUI Association. The SFST, SFST Refresher, ARIDE and DRE Curricula were all updated by the National Highway Traffic Safety Administration (NHTSA) in 2023.
