An interactive exploration of the new eLearning portal will be provided to feature the many opportunities within the PLP. 1C. Evidence-Based Practices are research based tools proven to reduce recidivism, improve the lives of individuals interacting with the criminal justice system and create safer communities. This session will also familiarize participants with the practical application of evidence-based practices in community supervision in an evolving framework.

1D. AHSS Teaching Techniques - Presenters: Cori Doughty, Court Administrator, Monroe County & Chris Shanley, Director, Allegheny County Pretrial Services. In the era of digital learning, teaching a DUI class effectively requires familiarity with various online tools and platforms. This workshop will provide instructors with the skills needed to conduct DUI classes remotely using Microsoft Teams and Zoom, and to manage administrative tasks such as obtaining signatures with Adobe Acrobat Reader. 2A. Treatment, Recovery Supports, and Recovery Success - Presenter: Dr. Aleisha Albertson, DHS, CCS, Regional Director of Inpatient Operations, Pyramid Healthcare. This workshop provides suggestions for instructors on how to teach DUI classes specifically tailored for offenders who only use cannabis and how to conduct CRN evaluations effectively. Participants will gain insights into the unique aspects of cannabisrelated DUI offenses and learn best practices for evaluation and education. P1a. Interlock for Law Enforcement - Presenters: Eileen Lee, Director, Ignition Interlock Quality
Assurance Program, Corporal John Witkowski, DRE, Pennsylvania State Police, Cori Doughty, Monroe
County District Court Administrator & Christopher Shanley, Director, Allegheny County Pretrial Services.
Act 33 was passed in September 2016. This mandated first time offenders of DUI to have Ignition
Interlock installed in their vehicle. What section do I cite for? What does the law specifically say? Are
there different sections I cite for? What am I actually looking at inside the vehicle? Has the law changed
since it passed? These questions will all be answered in this session.

P1b. Impaired Driving Case Law - Presenters: Ande Gonzalez, DRE, Lancaster County Assistant District Attorney & Nate Boob, Traffic Safety Resource Prosecutor, PA District Attorney's Association. This workshop is designed to present, interpret and discuss institutional issues related to traffic and drug and alcohol-related enforcement activities. Issues to be discussed include: DUI case law, implied consent, standardized field sobriety testing, Miranda issues, police liability and current decisions relating to safety issues. \*This session is designed for Alcohol Highway Safety School professionals, Treatment and Prevention specialists.

P1c. Updates for SFST, ARIDE & DRE Instructors - Dave Andrascik, PA DECP State Coordinator, Pennsylvania DUI Association. The SFST, SFST Refresher, ARIDE and DRE Curriculum was updated in 2023. There were some changes in the material, and there were changes in the instructor guides, formatting and power point slides. During this session, we will discuss the changes to SFST and ARIDE trainings, as well as discuss preparation techniques for successfully presenting the material in the newer formatting. \*This session is designed for currently certified SFST, ARIDE & DRE Instructors.

The Pennsylvania Liquor Control Board (PLCB) provides millions of dollars in alcohol education grants to communities, educational institutions and law enforcement agencies. The Bureau of Alcohol Education works to educate the public about the dangers of underage and dangerous drinking through a variety of other avenues, including a free annual alcohol educational conference, a prevention campaign - Know When. Know How. SM - targeted to underage drinking, the creation and distribution of a wide range of educational materials, Responsible Alcohol Management Program (RAMP) training and resources for licensees and training and technical assistance for organizations working to address the issues related to irresponsible alcohol consumption.

4A. Initiating & Sustaining Prevention and Rehabilitation Approaches for Driving Under the Influence - Presenter: Brian McCauley, Director, Heroes Program at PA Recovery Center. Examine prominent law enforcement issues in roadside search and seizure through a different lens. Take a walk through video analysis of what went right, what went wrong, and the constitutionality of it all.
